conferences, meetings and activities, adopting global priorities and international agendas, such as combating extremism and terrorism and resolving conflicts by peaceful means, and writing about women and youth empowerment issues. , the climate change agenda, the achievement of sustainable development indicators, the relationship of science, technology and innovation to issues of international peace and security, issues of the peaceful use of nuclear energy and the fight against nuclear proliferation, space science, etc.; All this has given Emirati diplomats the experience and competence to participate and contribute effectively in international forums and the ability to positively influence the international agenda. the future of Emirati diplomacy will be shaped by a range of factors, including technology, geopolitical shifts, and the country's continued growth and development. As the UAE becomes an increasingly influential player on the global stage, it will likely continue to leverage technology, promote regional stability, diversify its foreign relations, and enhance its reputation through soft power initiatives.
